#### ORDER:

Life Line Trust, Home for Girl Children, 3<sup>rd</sup> Cross Chandra Garden, Chinnatirupathi, Salem District – 636 008 registered under section 34(3) of Juvenile Justice (Care and Protection of Children) Act 2000 as amended in 2006 and rules therein, is renewed for the period from 10.03.2015 to 09.03.2020 vide SI.No.313/DSW/2015.

The Conditions under which Registration renewal is issued are:-

- The Management should run the institution in accordance with Juvenile Justice (Care and Protection of Children) Act 2000 as amended in 2006.
- Application for granting further continuance of registration should be submitted to this office three months in advance before the expiry of the registration.
- 3. This certificate should be displayed prominently for the information of parents/general public in the office room.

- 4. The following words may be mentioned in the name board of the Institution Life Line Trust, Home for Girl Children, 3rd Cross Chandra Garden, Chinnatirupathi, Salem District – 636 008 is Registered by the Commissioner of Social Welfare under Juvenile Justice (Care and Protection of Children) Act 2000 as amended in 2006 and rules therein, for a period from 10.03.2015 to 09.03.2020.
- Institution should follow rules / regulations issued by State Government / Commissioner for Social Welfare from time to time.
- The Institution is subject to inspection by the inspection authorities under the Act / Rules and by the persons / officers authorized by the State Government / Commissioner Social Welfare Officer.
- 7. Any admission / death / repatriation of the children in the institution and any discharge of children from the institution should be intimated to the concerned Child Welfare Committee and District Social Welfare Officer.
- 8. The infra-structure facilities should be maintained properly.
- To ensure proper education, child rights and necessary safeguards from child abuses.

#### 10. To Provide:-

- a. Clothing and Bedding. Section 41
- b. Sanitation and Hygiene. Section 42
- c. Nutrition and Diet Scale Daily. Section 44 :- (Menu chart should be display.)
- d. Medical Care. Section 45
- e. Education. Section 47
- f. Recreation facilities Section 49
- g. Management Committee to be formed Section 55.
- 11. To ensure water and sanitation facility and also safe drinking water.
- 12. Sufficient supervisory and sub staff should be maintained as per the Act.
- 13. To maintain the kitchen in a hygienic manner.
- 14. The personnel should be trained in handling fire safety facilities.

- 15. Rain water harvesting facilities should be maintained in the Institute.
- 16. The institution should not construct any thatched structure in future.
- 17. The management should produce all the children admitted in the home before the Child Welfare Committee concerned and obtain necessary orders within 3 months and if not the registration will be withdrawn and hitherto continue to produce children before Child Welfare Committee before admission & discharge. Now at present there are 3 number of Boys and 13 Number of girls. As per the space and facilities available 16 children can be admitted. However, without the concurrence of CWC, no more children should be admitted.
- 18. Structural Stability Certificate, Sanitary Certificate, Building License and No Objection Certificate from Fire Service Department should be renewed within 3 months intimation to be given to the District Social Welfare Officer. If not the registration will be withdrawn.

If the institution is found to violate any one of the above said conditions, the registration renewal issued is liable for cancellation.
